INSTRUCTIONS FOR FOREIGN / INTERNATIONAL CANDIDATES

Candidates who fall under at least one of the following categories can apply under the Foreign / International Student Category.

1. Foreign citizens,
2. PIO card holders and
3. OCI (Dual Citizens)
 - MSRUAS offers various course in UG /PG/ PhD Programmes. Admission to all programmes is based on eligibility norms and the University's selection process. Provisional Admission will be given to students based on predicted grades along with the transcript detailing percentage equivalence from the school/ college or University last attended. Candidates should submit the final results of the qualifying examination on or before July 10th (for UG courses) and July 20th (for PG courses) of the admission year.
 - Foreign Students seeking admission should have equivalent qualification and must be proficient in English. Candidates must have the minimum TOEFL score if they have not studied in English medium.
 - **Note:** The International Student category fee structure is binding for the full duration of the course / programme and cannot be transferred/ changed in between.
 - Candidates from the above listed categories, who possess Indian Educational qualifications and who are eligible to apply under the Indian States Category will have to pay the International Student Category Fee The decision of the Admission committee is final.
 - Kindly browse through the Selection process, Fee Structure and other details for your choice of programme on our website before, you proceed further.
 - **Security Registration**-It is a part of the normal mandatory process that within the stipulated time frame of arrival in India, the student has to register his/ her name with the police in the Foreigner's Registration Office (FRO) / Foreigner's Regional Registration Office (FRRO). The time frame may vary from 24 hours to 14 days of arrival depending on the country of origin. A student with a PIO card also must register at the FRRO. Only OCI card holders need not register. Ramaiah University of Applied Sciences would only provide necessary assistance in this regard. The applicable immigration processing fees and other related expenses have to be additionally borne by the student.

NRI CANDIDATES

Students who fall under any of the following classifications, at the time of application can apply under NRI Student category and are liable to pay the fees applicable to the category for the entire duration of the course

1. NRI defined under the Indian Income Tax Law
2. Either of the parents is outside India (except Nepal) on Work Permit/Resident Permit
3. Indian citizen financed by any Institution/ agency outside India, even if parents are Residents of India
4. To claim Indian Category fee, the candidates should demonstrate residence / domicile in India for the recent 7 years at least or have studied previous 7 years in India. (Not applicable for OCI, PIO and Foreign Nationals)

PROCEDURE FOR APPLYING AND SEEKING EQUIVALENCE CERTIFICATE

Admission Application Form submitted by Foreign / NRI students must be accompanied by an Equivalence Certificate from the Association of Indian Universities (AIU), www.aiu.ac.in

The students are advised to submit the following documents to the Association of Indian Universities for obtaining Equivalence Certificate:

- Degree/Certificate together with the year-wise Academic Transcript duly authenticated by the Indian Embassy in the Country or its concerned Foreign Mission in India.
 - Accreditation status of the University/Institute which the student has last attended.
 - Copies of the academic Certificates from Higher Secondary onwards (where necessary)
The SERVICE CHARGE for issue of Equivalence Certificate as applicable is payable through Demand Draft in favour of “Association of Indian Universities, New Delhi”.
- Application for Admission will be considered only after the Equivalence Certificate from AIU is submitted to MSRUAS.

COMPLETING THE APPLICATION FORM

- Fill in the Application Form after you satisfy yourself about your eligibility for admission to the program.
- If you have appeared in a qualifying examination and the result thereof is awaited, you may apply provisionally to go through admission process at your own risk.
- The Application Form has to be filled in your own handwriting in black ink and the undertaking is also to be signed by the candidate only.
- The instructions in the Application Form are self-explanatory. Please follow them strictly.
- It is mandatory to provide your email address (clearly) as it will be used by the Admission Office for any communication.
- Foreign students / Foreign University Degree holder should attach photocopies of academic transcripts & AIU Equivalence Certificate. University / Board / Marks filled in the Application Form will be considered for all procedures related to admission. Any discrepancy found during original document verification may result in cancellation of Admission
- You cannot apply more than once for the same program in one admission year.
