M.S. Ramaiah University of Applied Sciences (MSRUAS) created by an act in the State of Karnataka, India, came into inception in December 2013. The University provides holistic experience to its students, as the student in addition to his/her academic Programme has an opportunity to participate in research, skill development, real life problem solving and entrepreneurship.

The University has Faculties of: Engineering and Technology (FET), Art and Design (FAD), Management and Commerce (FMC), Hospitality Management and Catering Technology (FHMCT), Pharmacy (FPH), Dental Sciences (FDS), Mathematical and Physical Sciences (FMPS), Life and Allied Health Sciences (FLAHS), School of Social Sciences (SSS) and School of Law (SL). **Recently, Ramaiah Medical College, Ramaiah Institute for Nursing Education and Research and Ramaiah College of Physiotherapy have also become part of the University. Through these Faculties/Schools, the University offers Undergraduate, Postgraduate and Doctoral degree Programmes.**

The University has created Directorates of: Student Placement, Welfare and Career Advice (SPWCA), Training and Lifelong Learning (TLLL), Techno Centre, Sponsored Research, Quality, Educational Processes and Technologies to provide rich all-round experience to the students.

A. General Guidelines

A.1 Short Title and Commencement

- a. The regulations listed under this head are common to all disciplines of UG and PG Programme offered by the University.
- b. The regulations hereunder are subject to amendments adopted by the Academic Council of the University, from time to time, after obtaining approval of the Board of Management/Board of Governors. Such amendments will be effective from such date and apply to such batches of candidates, including those already undergoing the Programme, as may be determined by the Academic Council.
- c. The Academic Regulations herein have to be read always in conformity with the norms prescribed by the respective regulatory bodies (Apex Bodies).

A.2 Definitions

- a. **Branch** means a discipline of UG or PG degree Programme (e.g. Civil Engineering, Computer Science and Engineering, Electrical and Electronics Engineering, Electronics and Communication Engineering, Mechanical Engineering, Business Administration, Pharmacy, Dental Science, Bio Technology, Food Technology, Hospitality Management etc.)
- b. **“Programme”** means a set of courses a student is required to successfully complete to become eligible for award of the specific degree
- c. **“Programme Specifications”** mean the document that describes the educational aims, Programme objectives, learning outcomes and the detailed Programme structure for each Programme
- d. **“Commission”** means the University Grants Commission (UGC)
- e. **“University”** means the M. S. Ramaiah University of Applied Sciences (MSRUAS)
- f. **“Department”** means an academic unit, under a Faculty, responsible for delivering the Programme (e.g. Department of Mechanical and Manufacturing Engineering, Department of Physics, Department of Biotechnology)

- g. **“Faculty”** means the Academic Units of the University offering various academic Programme (e.g. Faculty of Engineering and Technology, Faculty of Arts & Design, Faculty of Pharmacy, etc.)
- h. **“Course”** means a subject, either theory or practical or both, listed under a Programme
- i. **“Course Specifications”** mean the document that describes the title, the learning outcomes, syllabus, teaching and learning methods and assessment methodology for each Course
- j. **“Statutes”** mean the MSRUAS Statutes
- k. **“Answer scripts”** means test, assignment or examination answer sheet or booklet
- l. **Apex Body/Regulatory Bodies** are as listed below:
 - i. UGC
 - ii. Engineering/Technical/Hospitality Management – AICTE
 - iii. Medical College – NMC
 - iv. Nursing College – INC/NNMC
 - v. Dental College – DCI/(NDC)
 - vi. B.VoC. – National Skill Development of India
 - vii. Any other Apex Body as and when it gets formed

1. The University follows the study schemes as indicated in Table 3 for UG and PG Programmes:
2. The study scheme applicable to a specific Programme is stated in the Programme Specifications relevant to the Programme.

A.6.4 Selection and Admission of Students to Various Programmes

A student can seek admission to a Programme of the University by satisfying the admission criteria under quota for Government of Karnataka, University and NRI. All the students for admissions are thus categorized either as Government quota or University quota. The admission of students to various Programmes listed in Table -3 shall be made before the commencement of the academic year through an entrance test before the admissions under the University quota. Selected candidates

- Selection of students for admission under the Government of Karnataka will be based on Karnataka Government notified admission tests like Common Entrance Test (CET).
- Selection of students other than Government quota is based on the admission policy of the University notified from time to time.
- **Foreign students seeking admission** under University quota should have equivalent qualifications approved by the Association of Indian Universities. Also, the students should have proof of proficiency in English, as per the norms of MSRUAS i.e., if the medium is not in English, the aspirant must undergo a test conducted by the University.
- Selected candidates shall complete the admission procedure within the prescribed date by paying the prescribed fees and completing all other admission formalities notified by the University. Failure to do so may lead to cancellation of the selection.

The eligibility criteria for admissions to each of the Programmes under various Faculty is provided under the respective sections of the Programmes.

A.7 Academic Calendar

Every year the Academic Calendar will be issued by the University by considering the specific requirements of each of the Faculty/Department. The academic calendar of all Programmes offered in semester scheme shall be synchronized with the admission notification issued before the commencement of each academic year. In addition, the academic calendar shall be synchronized with the allotment of candidates by the Government of Karnataka in the case of applicable Programmes.

- A semester consists of a minimum of 90 working days and an academic year is divided into two semesters. Each working week will have an average of 40 hours of instructional time.
- A supplementary term, as applicable, for those students who need to earn the required credits/eligibility norms, may be announced at the end of the academic year/ even semester for a duration of around eight weeks based on requirements.
- The University will publish the Academic Calendar applicable to all Programmes at the beginning of each academic year and is disseminated to all faculty members and students. It is also hosted in the RUAS portal and website.

A.7.1 Academic Calendar for Specific Programmes

The University will publish an Academic Calendar for specific Programmes as per the Scheme of each Programme.

A.8 Department Academic Advisory Planning Committee (DAAPC)

Each Department to create a DAAPC with the purpose to bring transparency and accountability in

Academics and Research matters of the Faculty/Department for its growth and for the growth of the faculty and students.

The constitution of the Committee is as listed below:

The decisions with respect to Academics, Administrative and Infrastructural needs will be deliberated and recommended by this committee to the Vice Chancellor. The terms of reference are as given below:

- **Terms of reference:**

1. The term of this committee shall be one year (January to December). The members at 3 & 4 in the composition table will be on rotational basis. However, the Chairman will have the discretion to invite additional members as may be necessary.
2. Registrar shall notify the committee in December each year.
3. At least one meeting in a month is to be conducted. Agenda to be sought by member secretary at least two weeks before the meeting. The chairperson will finalize the agenda and circulate to the members 3 days prior to the meeting. An emergency meeting may be convened on 24 hours' notice, if required.
4. 60% of the members shall form the quorum.
5. The Proceedings and MOM to be shared with the Registrar, PVC concerned and Vice Chancellor and all faculty members of the Faculty/Department.

- **Powers and Functions:**

1. To decide and report various academic research, student centric, faculty related matters.
2. To decide about new courses to be introduced, it's DPR, intake, market feasibility etc.
3. To take pro-active measures with respect to admissions in all Programmes in their domain.
4. To suggest teachers about tests, syllabi, checks on completion of courses and syllabi, exam processes and uniformity in evaluation, punctuality in conduct of classes in lecturers, Tutorials, Practical, identify the list of absentees, shortage of attendance.
5. Planning of Internships and semester projects for students.
6. To propose names of experts for BOS, Panel of Experts for Examinations, Panel of Examiners, and Faculty Experts for recruitment for consideration of Vice Chancellor.
7. To plan list of distinguished Experts for University lecture series.
8. To encourage faculty members to submit sponsored R&D projects for funding support, plan patent awareness lectures.

A.9 Design and Development of Academic Curriculum

Introduction of New Programmes or Revision of Existing Programmes will be accordance with the Curriculum Design Development and Deployment Policy of the University. Dean of the Faculty may propose to offer a new degree Programme and appoint a committee for formulating the curriculum of various courses for each degree Programme offered by that department.

The Department is required to discuss the curriculum in the Department Academic Advisory Planning Committee (DAAPC)

The committee is also required to seek and obtain the opinion of external academic and industry experts on the curriculum so formulated in the Board of Studies.

The curriculum is then presented to the Academic Council for its approval before the Programme is offered by the University.

The curriculum for every Programme may be reviewed after one complete delivery cycle, and

approval of the Academic Council is sought again.

A.9.1 Board of Studies

The BOS is constituted by the Dean of the Faculty for each of the Programmes offered by the Faculty

1. The Chairperson of the BOS shall be the HOD of the Department offering the Programme
2. The BOS is valid for two academic years and shall report to the Constituting Authority on all matters relating to its functioning. The BOS will be on a rotational basis for every two years.
3. The BOS is approved by the Vice-Chancellor.
4. The BOS shall have the following functions, powers and responsibilities:
 - I. Course Structure Development
 - II. Curriculum Development and Pedagogy
 - III. Review of Curriculum, Subject/Module notes, Teaching and Learning Methods, Teaching and Learning Facilities
 - IV. To interact with the concerned Faculty or Faculties to suggest and make improvements in the courses of study
 - V. To consult specialists who are not members of the Board
 - VI. To consider and take action upon any matters referred to it by the Dean
 - VII. The Committee may constitute one or more Sub-Committees comprising such members and with such terms and conditions and delegate to it such powers and functions as it may think fit.
 - VIII. Any other matter related to Curriculum Development and Delivery
1. The Chairperson shall conduct the meetings as it is deemed necessary and prepare the minutes of the meeting for further approval in the Academic Council
2. The Secretary of the BOS shall maintain all the minutes and other relevant documents related

to the functioning of the BOS and shall make these available to any authorized person.

3. A member of the Faculty who formulates the curriculum of a course, delivers and assesses students undergoing that course is known as “Course Leader”.

A.10 Programme Curriculum

The curriculum includes the following:

- **Programme Specifications** document where the Rationale, Programme aims, objectives, graduate attributes, Programme outcomes, Programme educational objectives, Programme specific outcomes, and the detailed Programme structure are described.
- **Course Specifications** document contains the course title, course outcomes, mapping of course outcomes with Programme outcomes and Programme specific outcomes, syllabus, teaching and learning methods and the assessment methodology for each of the course.

A.11 Programme Fee

- Details of the fees payable to each Academic Year of the Programme will be notified well in advance of the commencement of the Academic Year. The notification will be through the ERP software to all the students. For the first-year students, the information will be provided to the selected students by the admission department.
- The fees, once paid, will not be refunded under any circumstances.
- The continuation of a student’s registration in subsequent academic years is subject to payment of the prescribed Programme and registration fees for each of those years.

A.12 Credits for the Programme

A.12.1 Credit Definition

The number of hours per credit for theory, tutorials and laboratory/field work/workshop/project normally followed in MSRUAS is given below:

1. **For Theory Classes:** 1 credit is equivalent to 15 contact hours.
2. **For Tutorials:** 1 credit is equivalent to 15 contact hours.

3. **For Laboratory/Field Work/Workshop/Project Work and Allied Activities:** 1 credit is equivalent to 30 contact hours.

The regulations are to be read always in conformity with the norms of the respective regulatory (Apex) bodies that may be amended from time to time.

A.12.2.1 Credit Requirements

The total number of credits, as applicable, required to be earned by a student joining the Programme for the award of the Degree is shown in Table 2.

A.12.2.2 Lateral Entry – Duration and Credits

Wherever applicable, a student can be admitted directly to the third semester or higher year, under the lateral entry scheme. It is regulated by domain specific academic regulation stipulating the number of credits for the award of the degree, normal duration, and the maximum duration.

A.13 Registration of Courses During a Semester/Year

- A student has to register for all the courses in a given semester/year by remitting the required fee prescribed by the University. The schedule for registration for the courses in a semester/year will be specified in the Academic Calendar

A.14 Programme Delivery

The courses under each Programme are normally delivered in accordance with the timetable provided at the beginning of the semester. The delivery of a theory course may include but is not limited to:

1. Face-to-Face Lectures using Audio-Visuals
2. Quiz
3. Case Studies
4. Workshops
5. Demonstrations
6. Guest Lectures
7. Industrial Visit
8. Clinical Practice
9. Moot Court

Typically, a laboratory practice session is scheduled based on the number of credits it carries. Normally, one credit over the semester is equal to 30 hours. Laboratory work is normally delivered through a combination of instructions and demonstrations and is followed by student work. Students are also required to carry out project work which forms part of the curriculum.

A.14.1 Attendance Criteria

Mandatory minimum attendance is 75% of the classes in each of the courses in a given semester/year. The student will not be allowed to appear for SEE if the attendance requirement is not met with.

However, a shortfall in attendance, up to a maximum of 10%, maybe condoned by the Dean of the relevant Faculty with the approval of the VC, under special circumstances like medical emergencies, participation in sports, cultural activities, seminars, workshops and paper presentation etc. at the state, national or international level representing the University and with the prior permission of the concerned HOD and intimation to his/her Proctor/Mentor.

The basis for calculation of attendance shall be the period prescribed by the University in its annual calendar of events.

The attendance for the first-semester/year students is computed from the date of registration/orientation to the Programme.

The minimum attendance requirement for all the Programmes offered by MSRUAS is presented in Table 7. The attendance requirement for the Programmes mentioned below are available in the respective sections.

- Ramaiah Medical College
- Ramaiah College of Physiotherapy
- Ramaiah Institute of Nursing and Educational Research
- Ph.D
- B.VoC. Programmes

A.15 Assessment Criteria

A.15.1 Achievement Testing

During each semester, students' performance is assessed through Continuous Evaluation (CE) and a Semester/Year/Module/Trimester End Examination. The weightage for CE and the End Examination may vary from Programme to Programme as ratified by the Academic Council or the Regulatory Body. The assessment criteria for all the Programmes offered in MSRUAS under various Faculty is provided in the Table – 7 below.

1. Continuous Evaluation (CE)

- This includes Term Tests, Creative Work, Jury, Assignments, Multiple Choice assignments, laboratory assessments, problem solving, computer simulations, creative submission, virtual labs, multiple choice questions, viva-voce, quiz, seminars, mini projects, and other such evaluation methods designed for specific courses and conducted as per the norms of the University for the Assessment.

2. Semester/Year/Module/Trimester End Examination :

- This includes a written/Evaluation by Jury/Viva-Voce/Project review/Product

Demonstration/laboratory examination conducted as per the norms of the University for Assessment.

- Project work /dissertation may be offered as per the schemes prescribed in respective courses. It shall be evaluated by two examiners, one external and one internal appointed by the University. Wherever there is viva-voce, it shall be conducted by the Viva-Board consisting of the internal guide and one external expert from the panel of examiners and as approved by University.

3. Students appearing for courses in supplementary term are also assessed through CE and SEE.

However, CE component will be assessed through One Assignment and One Term Test as the duration of the Summer Semester/Supplementary term happens to be half the regular semester.

A.15.2 Examiners

A.15.2.1 Internal Examiners

The course leader is responsible for the setting of question papers for both CE and SEE/YEE/TEE/MEE, supervision of the examinations and valuation of the answer scripts, as described in the Programme Specifications as well as Course Specifications. The course leader may become the internal examiner for

the course. The question papers, set for each course, are reviewed and approved by an evaluation panel constituted by the Dean and approved by the VC.

A.15.2.2 External Examiners

The appointment and the approval of external examiners will conform to the guidelines of the associated Apex/Regulatory body for the respective Programme. Accordingly, the CE and/or SEE/YEE/TEE/MEE assessment of courses or its components will be carried out in the presence of external examiners.

A.16 Examination Manual/Regulations

Regulations pertaining to ALL ASPECTS of the pre-examination, examination and post-examination processes are presented in detail in the RUAS Examination Manual/Regulations. The following are some major issues covered in the RUAS Examination Manual/Regulations. The RUAS Examination Manual/Regulations is available on the University's Website.

These regulations are to be read always in conformity with the norms of the respective Regulatory bodies that may be amended from time to time.

A.17 Programme Quality Monitoring

A.17.1 Staff Student Consultative Committee

The Staff-Student Consultative Committee (SSCC) looks into the quality of the Programme delivered by each Faculty. The Dean of the Faculty chairs the meeting. The committee comprises the Dean, HODs, Class Representatives and other member(s) invited by the Dean.

1. SSCC meetings are scheduled as per Programme regulations and academic calendar.
2. SSCC meeting is treated as Formative Assessment of the Programme.

During the SSCC meetings, the following issues are discussed and suitable action plans are initiated:

1. Student Academic issues
 - Curriculum
 - Programme Delivery
 - Test and Assignment and their Assessment

2. Student Teaching and Learning Support
 - Programme Operations
 - Tests and Assignments
 - Library
 - ICT
 - Laboratories and Workshops
 - Student Feedback

3. Student Amenities
 - Hostel & Cafeteria
 - Sports & Recreation

4. Any other matter with the permission of the Chair

A.18 Eligibility to SEE

A student will be eligible to appear for the SEE under the following circumstances:

- a. For separate Theory and Laboratory Courses:
 - i. Has satisfied the attendance criteria of 75 %
 - ii. Has scored a minimum of 40 % in CE and has satisfied the attendance requirement
- b. For combination courses wherein Theory and Laboratory components are combined, the following criteria would be applicable for getting eligibility to SEE:
 - i. A minimum of 75 % attendance including attendance in both theory and laboratory components.

- ii. A minimum of 40 % marks in CE (marks scored in both theory and laboratory included) but has satisfied the attendance requirement.
- iii. In case the SEE for the Laboratory component is conducted before the SEE for Combined Courses and subsequently if the student is found to have not satisfied the requirements of CE (Combined Theory and Laboratory Components), the outcome of the already conducted SEE for Laboratory is considered null and void. This leads to the category of Re-Registration for the subsequent opportunity.

A.18.1 Pass Criteria for All Programmes

- **For Theory Courses:** A student is required to score a minimum of 40 % in CE and an individual minimum 40 % in SEE
- **For Laboratory Courses:** A student is required to score a minimum of 40 % in CE and an individual minimum 40 % in SEE
- **For Combination Courses** (Theory and Laboratory integrated Courses): A student is required to score a minimum of 40 % in CE (marks scored in Theory and Laboratory included) and an individual minimum 40 % in SEE (Theory and Laboratory included)
- **For AECC and Open Electives:** A minimum of overall 40% marks in CE+ SEE. Attendance for both CE and SEE is compulsory for the courses offered by RUAS.

A.19 Credits not Earned in a Course

A student will not earn the required credits and hence will be declared failed under the following scenario:

1. He/she has not satisfied the attendance requirements.
2. Not met the required performance in CE, SEE and (CE+SEE).
3. Since credits not earned in a course may be dependent on specific Programmes, the students have to refer the relevant guidelines applicable to a specific course of a specific Programme to earn the required number of credits.

A.20 Failure and Opportunities for Make-up

A student will be declared "Failed" in a course under the following circumstances:

1. He/she has not satisfied the attendance requirements of 75 % (Re-Registration).
2. Has not scored a minimum of 40 % in CE although the requirement in attendance has been satisfied (Re-Registration).
3. Not scoring an individual minimum of 40% marks in SEE
4. Is absent for SEE but has satisfied attendance and CE requirement
5. Not met the required performance in CE+SEE (Re-sit).
6. The requirements of minimum performance in Attendance, CE, SEE and CE+SEE for a pass in a course may be dependent on specific Programmes. The students have to refer to the relevant guidelines applicable to a specific course of a specific Programme.

The guidelines of the associated Apex/Regulatory Body, if any, may overrule the above clauses.

Students are given the following opportunities for passing a failed course:

7. Students under categories 1 and 2 shall again register for the course under Re-Registration (RR) category during the next opportunity.
8. If a student re-registers for any course, the earlier attendance and results in that course will be treated as null and void.
9. Students under categories 3, 4, and 5 shall register for the course under Re-Sit (RS) category and appear for the SEE in the next opportunity. The CE marks earned during the regular semester will be retained.
10. However, if the student falls under any of the above categories as well as not eligible for the higher academic year due to backlog of credits exceeding 15, such students are permitted to register for the courses during the next opportunity (regular semester and/or supplementary term). To earn credit for a course and to pass, such a student should satisfy the attendance,

CE and SEE requirements.

Note: Students registering for courses under RS or RR category are required to pay the prescribed examination fees.

For Combined Theory and Laboratory Course:

A student will be declared “Failed” in a course under the following circumstances:

1. Has not satisfied the attendance requirement of 75 % (Combined Theory and Laboratory Components) (not eligible for SEE);
2. Has not scored a minimum of 40 % in CE (Combined Theory and Laboratory Components) although he/she has satisfied attendance requirement
3. Not scoring a minimum of 40 % marks in SEE (Combined Theory and Laboratory Components)

Students are given the following opportunities for passing a failed course:

4. Students under category 1 and 2 shall be permitted to register for the courses during the next opportunity (regular or supplementary term) and satisfy the attendance, CE (Combined Theory and Laboratory Components) and SEE (Combined Theory and Laboratory Components) requirements for passing a course.
5. If a student re-registers for any course, the earlier results in that course will be treated as null and void and the same will be considered as withdrawn.
6. Students under category 3 above shall appear for the SEE (Combined Theory and Laboratory Components) in the next opportunity provided (regular or supplementary term) under Re-Sit (RS) category. The CE marks earned during the regular semester will be retained.

Note: Students appearing for Re-Sit or Re-registration are required to pay the prescribed examination fees.

A.20.1 Supplementary Term

- I. A Supplementary Term typically of eight weeks duration may be offered at the end of the even semester or the Academic Year and a student can re-register for a maximum of 15 credits in it. Courses offered in a Supplementary Term will be decided by the Course Leaders in consultation

with the HOD/Dean.

- II. Students who have not met the attendance/CE requirement and those who have not met the SEE requirement for certain courses during the Regular Semester(s) can register for a supplementary term to make up for the credit deficiency.
- III. Student registering for courses during a supplementary term are required to pay the prescribed fees in addition to the annual fees.

In a supplementary term, a student can either register under Re-Sit (RS) or Re-Register (RR) category based on the performance of the course in the previous regular semester.

- **Re-Sit (RS):** If a student has the attendance eligibility in any course in a regular semester and has met the minimum requirement of CE, but has failed in the SEE in that course during the regular semester, then the student is required to register for a Re-Sit (RS) to appear in the SEE component with the earlier CE carried forward to the next opportunity (either during the Supplementary Term or a regular semester in which the particular course is offered).
- **Re-Register (RR):** If a student does not have the attendance eligibility in a course and/or has not met the CE requirement in a regular semester, then the student is required to Re-Register (RR) to attend the classes in the Supplementary Term and also satisfy the requirements of CE to appear for the SEE in that course.

Note:

In the supplementary/summer term, as and when it is offered, a student is permitted to register for a maximum of 15 credits under Re-Registration category and register for any number of courses under Re-Sit category.

The provision, duration and the credit limits for the supplementary term, if applicable, shall be in conformity with the guidelines of the relevant Apex/Regulatory body, if any.

Students with backlog of more than 15, after the results of the supplementary term, cannot be permitted to the next higher year.

A.21 Announcement of Results

The office of the Controller of Examinations (COE) will announce the results of the students during a given semester/year on the Faculty notice board as well as on the University website.

A.21.1 Withholding of Results

The results of students may be withheld if the student:

1. Has been subjected to disciplinary action and a decision is pending.
2. Has dues to the University.
3. Has failed to meet the academic requirements.
4. For any other valid reason at the discretion of the Vice-Chancellor.

All pending results will be announced as soon as the issue in question is resolved to the satisfaction of the University.

A.22 Promotion Criteria

A.22.1 Promotion Criteria for Undergraduate Programmes

1. A student is permitted to carry-over all the courses from a given regular odd semester to the next regular even semester in an academic year.
2. The student is promoted to the second year with a maximum of 15 credits backlog from previous (first year) including AECC.
3. A student will be promoted to the third year, provided the student has passed all courses of the first year of study and carries 15 or fewer backlog credits of the second year of study including AECC.
4. A student will be promoted to the fourth year, provided the student has passed all courses of the second year of study and carries 15 or fewer backlog credits of the third year of study including AECC.

A.22.2 Promotion Criteria for Postgraduate Programmes

1. A student is permitted to carry over all the courses from a given regular odd semester to the

next regular even semester in an academic year.

2. A student is permitted to carry over all the courses from first year to second year.

A.23 Marking Scheme and Academic Awards

A.23.1 Marking Scheme

The University follows the absolute marking system and grades/class are awarded based on the marks obtained.

A.23.2 Academic Awards

The basis for awarding grades for each of the courses is shown in Table 9. Specific grade definitions and grade points applicable to specific Programmes are presented in the respective sections of the Programem.

The class/grades awarded at the end of the Programme shall be based on the aggregate marks of all the semesters/years of the Programme.

A.24 Withdrawal in a Semester/Year

- A student may withdraw from registering to a semester/year under prior intimation to the HoD and Dean, and with the prior approval of the Vice Chancellor

A.25 Free-ships and Scholarships

The Board of Management, in consultation with the Board of Governors, may consider offering free-ships / scholarships to deserving students who maintain a minimum level of academic performance on a yearly basis.

A.26 Student Transfers and Migration

Migration of students from another Institution/University to RUAS may be accepted if there are vacancies available in the requested Programme and subject to the submission of a No Objection Certificate from the Institution/University the student is presently studying in and meeting the Academic requirements of the Programme as per the norms of RUAS and/or stipulations of Apex/Regulatory body.

Students who would like to migrate to another University/Institution will be required to obtain a No Objection Certificate from the University (RUAS).

A.26.1 Regulations for Student Rejoining the Programme After Losing a Year(s)

When the student attains the eligibility for a promotion to his/her next year of studies after losing a year(s), then he/she joins the students of a corresponding junior batch. If the Academic Regulations are revised in between the period of loss of year(s), then the Academic Regulations applicable to the corresponding junior batch are also applicable to the rejoining student after attaining the eligibility.

These regulations are to be read always in conformity with the norms of the Regulatory bodies that may be amended from time to time.

A.26.2 Statement of Learning and Achievement (Transcript/Marks card)

Every student will be issued a Statement of Learning and Achievement (Transcript/Marks card) at the end of each semester/year containing the course code, course title, marks scored, grade awarded, credits earned and result.

A.26.3 Degree Certificate

- a. The Degree Certificate, issued under the University Seal, will have the student's name, University roll number, name of the degree awarded and class.

- b. The Degree Certificate will bear the signatures of the competent authority/authorities.

A.27 Convocation

- c. A Convocation ceremony will be held once every year. Students will be conferred their Degree by the Vice –Chancellor or his / her nominee (normally the Dean of the concerned Faculty) during the convocation ceremony. The degree will be awarded in the presence of the University's Mace.
- d. Graduating students who are unable to attend the convocation, in person, can apply for award of the degree in absentia after paying the prescribed fee.

A.28 University Awards

The University may recognize meritorious performance of students by conferring various awards. These awards will be presented to students during the convocation.

A.28.1 Donor Awards

For the award of prizes and medals instituted by donors, the conditions stipulated by the donors will be considered by the Board of Management and Board of Governors.

A.29 Other Academic Matters

A.29.1 Credit Framework for Online Courses

Some of the Apex/Regulatory bodies offer a provision for a credit framework for online courses. The students can register for online courses through Online Education Portals, such as MOOC, SWAYAM, NPTEL or international online platforms like:

- coursera.org
- uredit.com
- udacity.com
- edx.com

The online courses can be from:

1. Professional Core Elective Group but not limited to the list of Professional Core Elective

Courses specified by the department.

2. Open Elective Group but not limited to the list of Open Elective Courses specified by the University.
3. Ability Enhancement Compulsory Courses but not limited to the list of AECC specified by the department.

Note: The list of online courses the department wants to offer shall be identified and approval of the BOS and Academic Council to be obtained before offering such courses. The level of each online course to be assessed by the department to open the course for registration of the student in a semester.

The guidelines of the associated Apex/Regulatory Body, if any, overrule the above clauses.

A.29.2 Registration for Online Courses

Students are required to register with the recommended online platforms of their choice for the online elective courses on the approval by the respective Head of the Department.

A.29.3 Assessment of Online Courses

The registered students are required to undergo assessment specified by the online platform. Further, the students are required to consult the Head of the Department for completing the assessment process.

A.29.4 Corrections in Statement of Learning and Achievement and Certificates

Students can apply for corrections in any transcript/marks card and degree certificate issued by the University within six months from the date of issue. Corrections are normally due to typographical or clerical errors. In extraordinary circumstances, the Vice-Chancellor will have the discretion to decide appropriately for meeting the ends of natural justice.

A.29.5 Duplicate Transcripts and Degree Certificate

In the event of a student losing the original transcripts or degree certificate, he/she can apply for the issue of re-printed documents. Re-printed transcripts will be issued against payment of the prescribed fee. The reprints will carry the caption "Duplicate".

A.29.6 Conduct and Discipline of Students

The provision relating to discipline and code of conduct that applies to every member of the University is as described in Chapter 8 of the MSRUAS Statutes.

A.29.7 Termination from the Programme

A student will be required to withdraw from the Programme and leave the University on the following grounds:

1. Failure to earn the required number of credits within the prescribed maximum duration of the Programme permitted by the University's Regulations or the Apex/Regulatory body as the case may be
2. Failure to meet the standards of discipline prescribed by the University from time to time
3. Continuous absence affecting the overall performance in a semester or a year without prior approval of the University. The guidelines of the associated Apex Body, if any, may overrule this clause.
4. For any other valid reason at the discretion of the Vice-Chancellor.

A.29.8 Intellectual Property

The provision governing Intellectual Property that is generated by a member of the University is as described in Chapter 9 of the MSRUAS Statutes.

B.1.2 Lateral Entry – Duration and Credits

A student admitted directly to the third semester, under the lateral entry scheme, shall complete the Programme within a period of three academic years from the date of first admission to the Programme. However, the maximum period permitted is additional two years over and above the normal duration of the Programme, i.e., five years (N+2) from the date of first admission to the Programme. The credit requirement for a lateral entry student is indicated in Table 10.

For Lateral Entry scheme students, the credits of the courses indicated in Table 10 are not considered for promotion or re-registration credit limits. However, the students are required to earn the credits of these additional courses specified in Programme Specification for award of degree.

During each year, students' performance is assessed through CE and YEE. **The ratio of CE: YEE components is 10:90 for Theory + Practical/Clinical Courses and 10:90 for Practical Courses**

- **CE:**This includes term tests, assignments, viva-voce, quiz, seminars, mini projects, and other such evaluation methods designed for specific courses and conducted as per the norms of the University for the Assessment.
- **YEE:**This includes written/practical/clinical examinations conducted as per the norms of the University for Assessment in accordance with DCI regulations.

B.10.4 Attendance Requirement:

- The mandatory minimum attendance is 75% of the classes in each of the courses in a given year.
- The student will not be allowed to appear for YEE if the attendance requirement is not met with. However, a shortfall in attendance, up to a maximum of 10%, may be condoned by the Dean of the relevant Faculty under special circumstances like medical emergencies, participation in sports, cultural activities, seminars, workshops and paper presentations, etc. at the state, national or international level representing the University and with the

prior permission of the concerned HOD and intimation to his/her Proctor.

- iii. The basis for calculation of attendance shall be the period prescribed by the University in its annual calendar of events. For first year, students' attendance is computed from the date of registration to the Programme.

B.10.5 Eligibility for Year End Examination

A student with a minimum of 75% attendance in each course is eligible to appear for YEE irrespective of CE marks.

B.10.6 Pass Criterion

- i. **Core Theory Courses:** A student is required to score a minimum of 50% marks in CE and YEE together for each course.
- ii. **Practical/Clinical Courses:** A student is required to score a minimum of 50% marks in CE and YEE together for each course.
- iii. **AECC and Open Elective Courses:** A student is required to score a minimum of 40% marks for a pass in the course.

A student shall be considered to have successfully completed a Course and earned the credit(s) if he/she has passed the Course

B.10.7 Credits Not Earned in a Course

A student will be declared "Failed" in a course under the following circumstances:

- i. Not scoring a minimum of 50% in YEE although he/she has satisfied attendance and CE requirements
- ii. Is absent for YEE but has satisfied attendance and CE requirements

B.10.8 Opportunities for Makeup

A student is offered Re-Sit (RS) or Re-Register (RR) categories for makeup. The **eligibility criteria** for Re-Sit and Re-Register categories are as described below:

i. Re-Sit (RS):

- a. If a student has the attendance eligibility and has failed in any course/courses in the regular YEE, then the student is eligible to appear in the Re-Sit YEE exam with the earlier CE marks carried forward
- b. If a student has at least 75% of attendance in any course/courses in the regular year, then the student is permitted to attend the remedial classes and make up his attendance for that course/courses to become eligible to appear for Re-Sit YEE.
- c. A student is promoted to higher class (I BDS to II BDS, II BDS to III BDS and III BDS to IV BDS) with a carry forward of one course. He / She must clear the course in the regular YEE before appearing for the YEE of higher class in the Re-Sit YEE exam

ii. Re-Register (RR):

- a. If a student does not have the attendance eligibility (<75%) in any course/courses in a regular year, then the student is required to Re-Register (RR) in the next academic year and fulfill the attendance and CE requirements. All previous data pertaining to CE and attendance will become null and void.

Note: Additional Registration Fees: All students registering for Re- Register category are required to pay the prescribed fees.

B.10.9 Promotion Criterion

- I. A student is permitted to carry over a maximum of one theory course from one academic year to next academic year
- II. In the second year YEE, a student who fails to pass Preclinical Prosthodontics/ Preclinical Conservative Dentistry, will not be allowed to attend clinical dental postings, until the preclinical courses have been passed.
- III. A student will be promoted to the third year provided the student has passed all the courses of the first year of study.
- IV. A student will be promoted to the fourth year provided the student has passed all the

courses of the second year of study.

B.10.10 Student Transfers / Migration

Student Migration after completion of I year BDS: Students who would like to migrate to another University/Institution are required to comply with the University norms in this regard.

1. Migration from one dental college to other is not a right of a student. However, migration of students from one dental college to another dental college in India may be considered by the Dental Council of India. Only in exceptional cases on extreme compassionate ground*, provided following criteria are fulfilled. **Routine migrations on other ground shall not be allowed.**
2. Both the colleges, i.e. one at which the student is studying at present and one to which migration is sought, are recognized by the Dental Council of India.
3. The applicant candidate should have passed first professional BDS examination.
4. The applicant candidate submits his/her application for migration, complete in all respects, to all authorities concerned within a period of one month of passing (declaration of results) the first professional Bachelor of Dental Surgery (BDS) examination.
5. The applicant candidate must submit an affidavit stating that he/she will pursue 240 days of prescribed study before appearing at 2nd professional Bachelor of Dental Surgery (BDS) examination at the transferee dental college, which should be duly certified by the Registrar of the concerned University in which he/she is seeking transfer. The transfer will be applicable only after receipt of the affidavit.

Note 1:

- i. Migration is permitted only in the beginning of 2nd year BDS Course in recognized Institution.
- ii. All applications for migration shall be referred to Dental Council of India by college authorities.
- iii. No Institution/University shall allow migrations directly without the prior approval of the Council.

- iv. Council reserves the right, not to entertain any application which is not under the prescribed compassionate grounds and also to take independent decisions where applicant has been allowed to migrate without referring the same to the Council.

Note 2: *Compassionate ground criteria:

- i. Death of supporting guardian.
- ii. Disturbed conditions as declared by Government in the Dental College area.

Internship Migration: After successful completion of the four year degree Programme, each student has to undergo one year of compulsory rotatory internship as specified by Dental Council of India. (As specified in the course specifications)

In case the student wishes to pursue internship in any other dental institution recognized by DCI, he/she has to submit the following documents to the Dean of the Faculty:

1. No Objection Certificate from the Institution one wishes to pursue internship
2. Details of Internship Programme from the Institution

The Dean of the Faculty forwards the application to the Academic Equivalence Committee for consideration. Following the recommendation of the Academic Equivalence Committee the University will issue the letter accordingly.

B.10.11 Termination from the Programme

A student will be required to withdraw from the Programme and leave the University on the following grounds:

1. Failure to earn the required number of credits within the prescribed maximum number of attempts.
2. Absence for two or more years, in succession, during any part of the Programme without prior approval.
3. Failure to meet the standards of discipline prescribed by the University from time to time;

4. Failure to complete the Programme within the prescribed maximum duration permitted by the University's Regulations.

B.11.2 Course Assessment

The Programme is delivered in an annual scheme and assessed on yearly basis. In this scheme, the curriculum is delivered and assessed sequentially in accordance with the Programme timetable. In addition, at the end of 1st year Part I - Paper 1 will be conducted and at the end of 3rd year, a Programme end examination will be conducted by the University.

A student is required to pass Part I – Paper 1 exam and should have passed exams of component 1 of all the three years and should have 80% attendance to be eligible for Programme End Examination. The student is required to score a 50% in Part I – Paper 1 exam and simultaneously achieve 50% aggregate of all 3 theory papers of Part II, and 50% in practical/clinical and viva voce put together to successfully complete the component 2 for award of Degree.

Programme specialization teaching module:

The student's performance in the Programme Specialization Teaching Module is assessed through Component 1 (Continuous Evaluation (CE)) and Component 2 (Programme End Examination (CEE)) for both the theory, practical/clinical and Viva Voce.

- i. **Component 1 (CE):** This includes assignments, assessments, viva-voce, log-book/clinical records, and other such evaluation methods designed for specific scheme and conducted as per the norms of the University for Assessment.
- ii. **Component 2 (CEE):** This includes Theory, Practical / Clinical and Viva Voce examination conducted as per the norms of the University / DCI for Assessment at the end of Year 1 and Year 3 of the Programme. Theory part of Component 2 shall be divided into Part I and II. Part I shall consist of a theory assessment of Paper 1 in Basic sciences at the end of Year 1 while Part II shall consist of 3 theory papers along with Practical/Clinical assessment, Pedagogy and Viva Voce at the end of 3 years. The candidates shall have to secure a minimum of 50% in the Part I and II and shall have to pass the part 1 examination at least six month prior to the final Part 2 examination. (With Reference to Dental Council of India MDS Regulations 2017).
- iii. **Research module, Faculty common modules and Elective modules:** The assessment for these modules is through tests, presentations or any other method as specified in the module specification. The Course Specifications (CS) provide the details of Components-1 and 2 for all

modules.

B.11.3 Attendance Requirements

In the case of Programme Specialization Teaching Module, a student is required to have a minimum attendance of 80% to be eligible to write the examination. However, Dean in consultation with HOD can condone up to 10% under special circumstances. Students who fail to achieve the minimum attendance is required to Re-Register, attend the module and take up all the components of assessment at the next offering. In case of Research modules, Faculty common modules and electives, the attendance requirement is specified in the respective module specification document.

B.11.4 Missing of Course/Failure to Complete a Course

If a student is unable to complete a course due to any reason leading to non-assessment, the student is required to re-register for that course in the next offering by paying the prescribed fees.

Research module, Faculty common modules and Elective modules:

- i. If the student has not satisfied the attendance requirement of these modules, he/she has to attend the module in the next offering after the payment prescribed re registration fee, if any.
- ii. If the student has satisfied the attendance requirement and has failed to score 50% of the marks in the module, he /she has to re-sit for the module assessment after the payment of prescribed necessary fee if any.

B.11.4.1 Opportunities for Make-up

Programme specialization teaching module

Component 1:

A student will be eligible for the successive Programme Specialization Teaching Course of the Programme under the following circumstances:

- i. A student who has satisfied the attendance requirement but has failed to score minimum of 50% in Component 1 is required to re-sit and complete the theory assessment and viva voce in component 1 in the Re-sit category exam in the next

offering.

- ii. A student will have to Re-Register for the Programme if he/she has not satisfied the attendance requirement of a Programme specialization teaching course.

Component 2:

A student is declared as “failed” in the Programme under the following circumstances:

- i. Student does not score 50% in Part I Paper 1
- ii. If student has scored 50% in Part I exam and not scoring simultaneously 50% aggregate in Part II of theory and 50% in practical/clinical and viva voce put together.

Students are given the following opportunities:

- iii. Student failing to score 50% in Part I exam should clear the same six months prior to appearing for Part II exam
- iv. Students failing to score aggregate of 50% in Part II of theory and 50% in practical/clinical and viva voce put together shall retake the exam in the next opportunity provided as RS (Re-Sit) category.

Note: Students appearing for Re-Sit examination of Component 2 are required to pay the prescribed examination fees.

Research module, Faculty common modules and Elective modules:

- v. If the student has not satisfied the attendance requirement of these modules, he/she has to attend the module in the next offering after the payment prescribed re registration fee, if any.
- vi. If the student has satisfied the attendance requirement and has failed to score 40% of the marks in the module, he /she has to re-sit for the module assessment after the payment of prescribed necessary fee if any.

B.11.5 Pass Criterion**Programme specialization teaching module:**

- i. Component 1: A student is required to score a minimum of 50% marks (calculated as the total of assignments and tests in the course).
- ii. Component 2: However a student is required to score 50% in Part I and 50% aggregate in Part II, and 50% in Practical/Clinical, Pedagogy and viva voce put together. (With Reference to Dental Council of India MDS Regulations 2017).

Research module, Faculty common modules and Elective modules:

- i. A student is required to score a minimum of 50% marks calculated as per assessment norms of the module indicated in the module specifications.

B.11.6 Criteria for Progress to Next Term

Students should successfully complete Programme specialization teaching course of a year to become eligible to progress to next year.

B.11.7 Award of Class

The final award will include a mention of class based on the average of the marks scored by the student in the Programme end examination. The basis for awarding classes is shown in the Table 25:

B.12.3 Pass Criterion

- A student shall be declared Pass in a course and eligible for earning a grade in
 - Theory Course: Securing 50% including both CE+SEE
 - Laboratory Course: Securing 50% including both CE+SEE
- In case a student fails to secure the minimum 50% in any Theory or Practical course, the student shall reappear for the Supplementary examination. However, the internal assessment marks scored earlier shall be carried over and the student is entitled for earning the grade on passing the course.
- A student shall be considered to have successfully completed a Course if the

candidate earned the credit(s) and has passed the Course.

B.12.4 Credits Not Earned in a Course

A student will be declared “Failed” in a course under the following circumstances:

- a. Not scoring a minimum of 50% in SEE and IA/CE together although he/she has satisfied attendance requirement.
- b. Is absent for SEE but has satisfied attendance requirement.
- c. Has not satisfied the attendance requirement on the Theory and Laboratory courses.

Students are given the following opportunities for passing a failed course:

- II. A student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However, the student shall not be eligible to attend the courses of VII semester until all the courses of I, II, III and IV semesters are successfully completed.

- V. A lateral entry student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However, the student shall not be eligible to attend the courses of VII semester until all the courses of III and IV semesters are successfully completed.

- VI. A lateral entry student shall be eligible to carry forward all the courses of V, VI and VII semesters till the VIII semester examinations. However, the student shall not be eligible to get the course completion certificate until all the courses of III, IV, V and VI semesters are successfully completed and the student should have met the attendance requirement of the VII and VIII semester courses.
- VII. A lateral entry student shall be eligible to get the CGPA upon successful completion of the courses of III to VIII semesters within the stipulated time period as per the norms specified

B.13.3 Credits

B.13.3.1 Credit Definition

Courses are broadly classified as Theory and Practical. Theory courses consist of lecture (L) and Practical (P) courses consist of hours spent in the laboratory.

Credits (C) for a course is dependent on the number of hours of instruction per week in that course and is obtained by using a multiplier of one and half (1.5) for lecture including tutorial class and a multiplier of one (1) for practical (laboratory) hours. (Fraction thereof in credits is rounded to higher digit). A student is required to earn a minimum of 276/279 credits to become eligible for the award of the Degree.

B.13.3.2 Pass Criterion

A student shall be declared to have passed examination if he or she secures at least 50% marks in each of the courses separately in the theory examinations, including sessional marks and at least 50% marks in each of the practical examinations including sessional marks.

- i. Theory and Practical are considered as individual courses for the purpose of pass criteria.
- ii. For Theory and Practical Courses, candidates who have secured a minimum of 50% marks including sessional (CE+YEE) shall be declared to have passed in that course

Note: In case a student fails to secure a minimum of 50% in any Theory or Practical course, then the student shall reappear for the supplementary examination of that course. However, the Internal Assessment/Continuous Evaluation marks shall be carried forward and the student shall be entitled for grade obtained upon passing of the course.

A student shall be considered to have successfully completed a Course if the candidate earned the credit(s) and has passed the Course.

B.13.3.3 Credits Not Earned in a Course

A student will be declared "Failed" in a course under the following circumstances:

- a. Not scoring a minimum of 50% in YEE and IA/CE together although he/she has satisfied attendance requirement;

- b. Is absent for YEE but has satisfied attendance requirement;
- c. Has not satisfied the attendance requirement (not eligible for YEE);

Students are given the following opportunities for passing a failed course:

- Students in the above categories shall appear for the supplementary examination in the next opportunity provided and are declared as Supplementary category.
- Students appearing for Supplementary examinations are required to pay the prescribed fees.

B.13.3.4 Pass/Failure and Supplementary Examination

The eligibility criteria and procedures for supplementary examination are as per the Pharmacy Council of India (PCI) norms and as follows:

B.13.3.4.1 Minimum marks for passing examination

A student shall be declared to have passed examination if he or she secures at least 50% marks in each of the courses separately in the theory examinations, including sessional marks and at least 50% marks in each of the practical examinations including sessional marks.

B.13.3.4.2 Eligibility for Allowed To Keep Terms (ATKT)

- i. No student shall be admitted to any examination unless he/she fulfills the norms of attendance criteria.
- ii. All students who have appeared for all the subjects and passed the first-year annual examination are eligible for promotion to the second year and, so on. However, failure in more than two subjects shall debar him or her from promotion to the next year classes.
- iii. A student shall be eligible to get his/her CGPA upon successful completion of the courses of I to V year within the stipulated time period as per the norms.
- iv. Grade "F/Ab" should be considered as failed and treated as one head for deciding ATKT. Such rules are also applicable for those students who fail to register for

examination(s) of any course in any academic year.

- v. In case a student fails to secure the minimum 50% in any Theory or Practical course, then he/she shall re-appear for the year end examination of that course during the conduct of supplementary examination. However, his/her marks of the Internal Assessment shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.

The selected candidates shall complete the admission procedure within the specified date by paying the prescribed fees and completing all other admission formalities notified by the University. Failure to do so may lead to cancellation of the selection.

B.13.7 Pass Criterion

- i. A student shall be declared PASS and eligible for getting grade in a course of M. Pharm Programme if he / she secures at least 50% marks in that particular course including internal assessment/Continuous Evaluation. For example, to be declared as PASS and to get grade, the student has to secure a minimum of 50 marks for the total of 100 including Internal assessment and semester end theory examination and has to secure a minimum of 75 marks out of the total of 150, including internal assessment and semester end practical examination.

- ii. In case a student fails to secure the minimum 50% in any Theory and Practical course, then he/she shall reappear for the Supplementary examination of that course. However, his/her marks of the Internal Assessment/Continuous Evaluation shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.

B.13.8 Credits Not Earned in a Course

A student will be declared “Failed” in a course under the following circumstances:

- Not scoring a minimum of 50% in SEE and IA/CE together although he/she has satisfied attendance requirement;
- Is absent for SEE but has satisfied attendance requirement;
- Has not satisfied the attendance requirement in Theory and Laboratory courses.

Students are given the following opportunities for passing a failed course:

- Students in the above categories shall appear for the supplementary examination in the next opportunity provided and are declared as Supplementary category.

B.13.10 PCI norms for Pass, Revaluation, Term and Improvement of Sessional marks

The eligibility criteria and procedures for supplementary examination and improvement of sessional marks are as per the Pharmacy Council of India (PCI) norms and as follows:

- **Minimum marks for passing examination**

A student shall be declared to have passed in M. Pharm examination and eligible for getting grades in a course if he/she secures at least 50% marks (including component -1 marks) in that particular courses.

- **Revaluation / Retotaling of answer papers**

There is no provision for revaluation of the answer papers in any examination. However, the candidates can apply for retotaling by paying prescribed fee.

B.13.10.1 Eligibility for Allowed To Keep Terms (ATKT)

- i. No student shall be admitted to any examination unless he/she fulfills the norms of attendance criteria.
- ii. A student shall be eligible to carry forward all the courses of **I and II** semesters till the **III semester examinations**. However, he/she shall not be eligible to attend the courses of IV semester until all the courses of I, II and III semesters are successfully completed.
- iii. A student shall be eligible to get his/her CGPA upon successful completion of the courses of I to IV semesters within the stipulated time period as per the norms.
- iv. Grade "AB" should be considered as failed and treated as one head for deciding ATKT. Such rules are also applicable for those students who fail to register for examination(s) of any course in any semester.
- v. In case a student fails to secure the minimum 50% in any Theory or Practical course, then he/she shall re-appear for the semester end examination of that course during the conduct of supplementary examination. However, his/her marks of the Internal Assessment shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.

B.13.10.2 Improvement of sessional marks

A student shall have the opportunity to improve his/her performance only once in the sessional

exam component of the internal assessment. The re-conduct of the sessional exam shall be completed before the commencement of next semester end theory examinations.

B.13.11 Promotion Criteria

A student shall be eligible to carry forward all the courses of I and II semesters till the III semester examinations. However, he/she shall not be eligible to attend the examination of the IV semester course until all the courses of I, II and III semesters are successfully completed.

B.15.5 Failure and Opportunities for Make-up

A student will be declared “Failed” in a course under the following circumstances:

1. Has not satisfied the attendance requirement of 75 % (not eligible for SEE)
2. Has not scored an overall minimum of 40 % in CE and SEE together.
3. Is absent for SEE but has satisfied attendance and CE requirements

Students are given the following opportunities for passing a failed course:

1. Students under category 1 and 2 shall be permitted to register for the courses during the next opportunity (regular or supplementary term) under Re-Reg (RR) category. The students have to satisfy the attendance, CE and SEE requirements for passing a course.
2. Students under categories 3 above shall appear for the SEE in the next opportunity provided (regular or supplementary term) under Re-Sit (RS) category. The CE marks earned during the regular semester will be retained.
3. If a student re-registers for any course, the earlier results in that course will be treated as null and void and the same will be considered as withdrawn.

B.15.6 Supplementary Term

A Supplementary Term typically of eight weeks duration may be offered at the end of the even semester or the Academic Year and a student can re-register for a maximum of 15 credits in it. Students who could not pass in certain courses during the Regular Semester(s) can register during a Supplementary Term to make up for the credit deficiency. Courses offered in a Supplementary Term will be decided by the Course Leaders in consultation with the HOD/Dean.

In a supplementary term, a student can either register under Re-Sit (RS) or Re-Register (RR) category

based on the performance of the course in the previous regular semester.

- **Re-Sit (RS):** If a student has the attendance eligibility in any course in a regular semester but has failed or absent in the SEE in that course during the regular semester, then the student is required to register for a Re-Sit (RS) to appear in the SEE component with the earlier CE carried forward to the next opportunity (either during the Supplementary Term or a regular semester in which the particular course is offered).
- **Re-Register (RR):** If a student does not have the attendance eligibility in any course, then the student is required to Re-Register (RR) to attend the classes in the Supplementary Term and also satisfy the requirements of CE and appear for the SEE in that course.

Note: In the supplementary/summer term, as and when it is offered, a student is permitted to register for a maximum of 15 credits under Re-Registration category and register for any number of courses under Re-Sit category.

B.15.7 Promotion Criteria

- i. A student is permitted to carry over all the courses from a given regular odd semester to the next regular even semester in an academic year.
- ii. A student is permitted to carry over all the courses from first year to second year.

B.15.8 Regulations for a Student Rejoining the Programme after losing a year

As per the promotion criterion, a student is not promoted to the next year (second year) of studies if he/she has more than 15 backlog credits. Such a student loses an Academic Year. When the student attains the eligibility for a promotion to his/her next year of studies, then he/she joins the students of a corresponding junior batch. If the Academic Regulations are revised in between, then the Academic Regulations applicable to the corresponding junior batch are also applicable to the rejoining student after attaining the eligibility.

D.1.1.3 Attendance Requirement:

- The mandatory minimum attendance for each type of course is as follows:
 - Theory : 75 %
 - Practical/Clinical : 80%
 - AETCOM Modules : 80%
- The student will not be allowed to appear for summative examination (final exam.) if the attendance requirement is not met with.
- The attendance of the students will be computed from the date of the registration to the program.

D.2.1.8 Credits Not Earned in a Course

A student will be declared “Failed” in a course under the following circumstances:

- ii. Is absent for YEE but has satisfied attendance and CE requirements;

- iii. Has not satisfied the attendance requirement (not eligible for YEE);

D.3.2 Selection of Students

- University Quota

There shall be an eligibility test for students seeking admission under University quota for admission to the BPT course in the year. Details of the same will be provided at the University website.

- Government Quota

In the case of students seeking admission under Government Quota, the admission process is done under the regulations of Karnataka State Government.

D.3.3 Admission to Programme

Selected candidates shall complete all the admission formalities within the prescribed date including payment of prescribed fees notified by the University. Failure to do so may lead to cancellation of the selection.

D.3.4 Intake of Students to the Course

The intake of students to the course shall be in accordance with the approved norms stipulated by the University and Department of Higher Education, Government of Karnataka. The intake for the Bachelor of Physiotherapy Programme in the College shall be 40 students per academic year.

D.3.5 Academic Calendar

The Academic Calendar will notify the important dates to assist students and faculty members. These include dates for registration of Programmes /courses, deferral of a course or project(s) and last dates for withdrawal from Programmes. This will enable students to be well prepared, minimize their chances of missing course assessment and project assessment schedules.

D.3.6 Course Assessment

- **Component 1: Continuous Evaluation**

- There shall be regular periodic examinations conducted throughout the course. These shall be considered as formative assessments during each year. The formative assessments will be conducted in the form of periodic tests consisting of theory, practical, assignments, group discussions and project work. It is mandatory for a student to appear for a minimum of two formative assessments. The average of the two examination marks will be reduced to 20 for Theory and 10 for Practical/Clinical subjects.

An aggregate of minimum 35% marks in theory and practical separately is a pre-requisite to appear for the year end examination.

- **Component 2: Year End Examination SCHEDULE OF EXAMINATION**

There will be two examinations in a year (annual and supplementary), to be conducted as per notification issued by the University from time to time. The First Year Examination of BPT course shall be held at the end of **Year One**. The examination for core courses shall be conducted by the University.

- **Component 3: Supplementary Examination**

There will be a supplementary examination, **six months** after the Year End Examination. Students with carry over subjects and failure in year- end examination will be eligible to take the supplementary examination. Students who were not eligible to appear in year-end examination due to attendance shortage or for not securing 35% eligibility criteria of the formative examination , will be permitted to appear in the subsequent supplementary after fulfilling the eligibility criteria.

D.3.7 Attendance Requirements

A candidate is required to attend a minimum of 80% of training and of the total classes conducted during each academic year of the BPT course. Provided further, leave of any kind shall not be counted as part of academic term without prejudice to minimum 80% of training period every year. Any student who fails to complete the course in this manner shall not be permitted to appear the University Examinations. A candidate who does not satisfy the requirement of attendance in one subject or more will not be permitted to appear for the said subject/subjects at the Year End Examination. He / She will be required to make up the deficit in attendance in the said subject/subjects to become eligible to appear for the same in the subsequent supplementary examination.

Eligibility Criteria for appearing in the Year -end examination

The student shall complete all the required courses, attendance and formative assessment requirements for eligibility to appear in the year - end examination

D.3.7.1 Pass Criteria

1. Core Courses

A candidate is declared to have passed theory paper, if she/he secures a minimum of **40 % of the marks in theory and an overall aggregate of a 50% in theory** and continuous evaluation put together. For a pass in practical (where applicable), the marks scored in the university conducted practical examination, the continuous assessment (practical) and viva voce, **the candidate should have scored an aggregate of 50 % marks put together.**

D.3.7.2 Promotion Criteria (Carry Over)

A candidate who has failed in an academic year is permitted to carry any **two** of the five core courses in year I and III. The student is promoted to the next academic year. However. The student shall have to pass the carry over courses in the supplementary examination to be eligible to appear in the Year End Examination of the subsequent year.

In year II a student can carry over only **one** of the four core courses. The student is promoted to the III year; however, the student shall have to pass the carry over course in the subsequent supplementary examination to be eligible to appear in the year end examination of III year.

D.3.7.3 Failure in Year End Examination

A candidate who has failed in **more than two subjects in Year I and III** and **more than one subject in Year II** in a given academic year will be considered as Fail. He/she will be eligible to write the examination of the failed subjects at the subsequent supplementary examination.

D.3.8 Award of Class:

The final award for degree will include a mention of class based on the average of the marks scored by the student at the Programme end examination. The basis for awarding classes is shown in the Table 56 below:

D.4.1.2 Selection of Students

○ University Quota

There shall be an eligibility test for students seeking admission under University quota for admission to the MPT course in each academic year. Details of the same will be provided at the University website each academic year.

○ Government Quota

The admission process of students under the government quota as per the regulations of the State Government.

D.4.2 Admission to Programme

Selected candidates shall complete all the admission formalities within the prescribed date including payment of prescribed fees notified by the University. Failure to do so may lead to cancellation of the selection.

D.4.3 Course Registration

The Programme is delivered through four courses, one common and three courses specific to each program. The students shall register for the courses in accordance with the prescribed procedure.

D.4.4 Course Assessment

Component 1: Continuous Evaluation

The learning progress of each student is monitored through continuous appraisal and regular assessment. A Log-book will be maintained by the student and will be duly signed by faculty member to ensure that the various prescribed activities are undertaken. Completion of the prescribed activities including the Dissertation work to the expected standards is a pre-requisite for appearing in the Programme End Examination.

Component 2: Programme-End Examination (PEE)

This includes Theory, Practical / Clinical and Viva Voce examination conducted as per the norms of the University for Assessment at the end of Year two of the Programme. Component 2 shall consist of:

- Four theory papers of three-hour duration each
- Two Practical and Clinical assessment
- Viva Voce
- Obtaining a minimum of 40% marks in each theory paper **AND** not less than 50% cumulatively in all the four papers together **AND** obtaining of 50 % marks in Practical /clinical examination **including** Viva Voce shall be mandatory for passing the PEE as a whole.

D.4.5 Attendance Requirements

A candidate is required to attend a minimum of 80% of training and of the total classes conducted

during each academic year of the MPT course. Provided further, leave of any kind shall not be counted as part of academic term without prejudice to minimum 80% of training period every year. Any student who fails to complete the course in this manner shall not be permitted to appear the University Examinations. A candidate who does not satisfy the requirement of attendance for the course of study will not be permitted to appear for the final Examination to be held at the end of the 2-year course. He / She will be required to make up the deficit in attendance to become eligible to take subsequent examination.

D.4.6 Dissertation

The Dissertation is aimed to train a graduate student in research methods and techniques. It includes identification of a problem, formulation of a hypothesis search and review of literature getting acquainted with recent advances, designing of a research study, collection of data, critical analysis, and comparison of results and drawing conclusions. Every candidate pursuing MPT degree course is required to carry out work on a selected research project under the guidance of a recognized postgraduate teacher. This may include quantitative research, qualitative research, systematic review or empirical research. The results of such a work shall be submitted in the form of Dissertation three months before the Programme-end examination on or before the dates notified by the university. Detailed guidelines and templates for synopsis and Dissertation are provided by the University. The Dissertation shall be examined by a minimum of two external examiners. A candidate shall be allowed to appear for the Theory and Practical/Clinical examination only after the acceptance of the Dissertation by the examiner.

D.6.1.2 Academic Calendar

The Academic Calendar will be synchronized with admission notification and allotment of candidates by the Government of Karnataka in each academic year.

D.6.1.3 Course Assessment

A course will undergo both Continuous evaluation (CE) and Summative evaluation (SE).

The ratio of CE: SE is given below for each type of courses.

- i. For Theory courses: **CE:SE = 25 : 75**
- ii. For Practical courses (Clinical Specialty): **CE:SE = 100 : 100**

- iii. For Practical courses (Nursing Education): **CE:SE = 50 : 50**

D.6.1.4 Attendance Requirements:

A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical/ clinical in each subject is essential for appearing in the examination.

D.6.1.5 Improvement in Internal Assessment

A candidate, who failed in the University exams, wants to improve his/her Internal assessment, shall be eligible for one improvement test before appearing for the supplementary examinations.

D.6.1.6 Eligibility for year-end examination

- A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical/ clinical in each course is essential for appearing in the examination.
- A candidate must have secured 50% marks in internal assessment

D.6.1.7 Pass Criteria

- i. Theory: 50% in theory component.
- ii. Theory and practical: 50% pass in each of the theory and practical component separately.
- iii. If the candidate fails in either practical or theory paper, he/she has to reappear for both the papers (theory and practical).

D.6.1.8 Supplementary Examination

- Supplementary examination shall be conducted and interval of not less than 4 to 6 months of year end examination.

D.6.1.9 Promotion Criteria

1. Candidate who fails in more than two courses shall not be promoted to the second year. However, the candidate shall not be allowed to appear for the Second year examination till such time that he/she passes all courses of the first year M.Sc. nursing examination.
2. Supplementary examination shall be conducted at an interval of not less than 4 to 6 months from the completion of year end examination.
3. If a student loses an Academic Year because of the eligibility for promotion to his/her next year of studies, he/she shall join the students of a corresponding junior batch. If the Academic Regulations are revised in between, the previous Academic Regulations are applicable to the rejoined student.

D.6.1.11 Extension of Course

- i. Maximum no. of attempts per course is three (3) inclusive of first attempt.
- ii. The maximum period to complete the course successfully should not exceed 4 years

D.6.1.12 Change of Programme

A change of Programme, from one specialization to another, may be requested by a student. However, a request for Programme change may only be permitted, subject to availability of vacancies and if the request was made prior to commencement of Programme. Such requests can be made through an application to be submitted to the Dean (Faculty of Nursing) at least

two weeks in advance.

D.6.1.13 Withdrawal from the Programme

A student undergoing the Programme is allowed to withdraw at any point during the Programme of study after submitting a request. Permission to withdraw shall be given by the Dean (Faculty of Nursing) after obtaining the approval of the Dean of the concerned Faculty. Any fees and other charges collected for that academic year shall not be refundable. Such students shall pay the remaining years' fee.

E.1.1 Eligibility Criteria for Ph.D. Programmes

A candidate seeking admission to the Ph.D. Programme should have obtained at least 55% or its equivalent grade 'B' in the UGC 10 point scale of Master's Degree in the subject area of research he/she intends to pursue. A candidate with a 4 year/8 semester Bachelor's Degree in Research with a minimum CGPA of 7.5 out of 10 is also eligible to apply. However, relaxation for SC/ST/OBC, EWS, and differently abled section shall be adhered as per the UGC and local State Government Regulations. In addition, the candidate shall also be required to secure the minimum stipulated score in the written test and/or interview that may be specified by the respective Department of the University. Entry level qualifications for the various specialties courses are indicated in the following table 69:

E.1.2 Selection – Admission Committee for Ph.D. Programme

Deans of the Faculty/School, HoDs and Faculty Members with Ph.D. and Coordinators of Doctoral Research Programme constitute Selection and Admission committee for shortlisting of candidates for Doctoral Research Programme.

The Composition of the Admissions and Selection Committee is as follows:

1. HoD shall act as the Chairperson
2. Ph.D. Coordinator of the Department shall act as Member - Secretary
3. All Faculty Members with Ph.D. Shall act as Members
4. Nominee of the Vice Chancellor

E.1.3 Duration, Course Work and Minimum Standards for Ph.D.

The number of the credit requirements as a part of course work for the Ph.D. Programme is 16 credits.

The coursework shall be treated as a prerequisite for Ph.D. preparation

- i. Students who register for Ph.D. directly from four-year undergraduate with research shall have to undertake 6-8 credit courses (at Ph.D. level) about relevant skills/research techniques/domain-specific subjects offered by the University. All Ph.D. entrants irrespective of discipline shall be required to take credit-based courses in teaching/education/pedagogy/writing related to their chosen Ph.D. subject during their doctoral training period
- ii. Other courses (physical/online) shall be advanced-level courses preparing the students for the Ph.D. degree
- iii. All courses prescribed for Ph.D. course work shall conform to the credit hour instructional requirement and shall specify the content, instructional, and assessment methods. They shall be duly approved by the authorized Board of Studies and Academic Council and notified in the micro-site of the Faculty/School
- iv. The Department where the scholar pursues his/her research shall prescribe the course(s) to him/her based on the recommendations of the Doctoral Committee (DC) of the research scholar
- v. All candidates admitted to the Ph.D. Programmes shall be required to complete the course work prescribed by the Department during the initial one or two semesters. In case of pandemic like situation, provision of blended mode should be made available.

- vi. Candidates already holding M.Phil. Degree and admitted to the Ph.D. Programme, or those who have already completed the course work in M.Phil. and have been permitted to proceed to the Ph.D. in an integrated course, may be exempted by the Department from the Ph.D. course work
- vii. Credits in the course work, including research methodology courses shall be finalized after a combined assessment by the Doctoral Committee and the Department and the final grades shall be communicated to the University
- viii. A Ph.D. scholar has to obtain a minimum of 55% of marks or its equivalent grade in the UGC 10-point scale (or an equivalent grade/CGPA in a point scale wherever grading system is followed) in the course work in order to be eligible to continue in the Programme and submit the thesis

E.1.4 Doctoral Committee

For each Research Scholar, the Doctoral Committee (DC) is constituted as follows:

- i. HoD shall act as the Independent Chair who is knowledgeable in the rules and regulations of the Ph.D. Programme pertaining to the University
- ii. Three Examiners approved by the HoD, who are reasonably conversant with the research area of the Scholar
- iii. Supervisor(s) of the Research Scholar (one of the Supervisors shall be designated as the Main Supervisor)
- iv. The Independent Chair, any two of the three Examiners and the Main Supervisor form the quorum. Convening the DC Meeting is the responsibility of the HoD. On completion of the review, the Main Supervisor shall forward the signed DC report to the HoD. The main supervisor shall also maintain the individual Scholar's progress file.

E.1.5 Assessment of Progress of Students of Doctoral Programme

Each Research Scholar is required to make a presentation on the progress made in his/her research topic to the Doctoral Committee at the end of each semester in the format prescribed by the

Department. The Supervisors are only observers at the Doctoral Committee Meeting and they do not have the right to defend or prompt the Research Scholar when he/she is presenting the report during the assessment. The Doctoral Committee shall allow the Research Scholar to make a 15 minute presentation in a specified format and this is followed by about 30 minutes of question and answer session. At the end of the meeting of Doctoral Committee, the Panel shall declare the result (Pass or Fail) and award the credits earned. If the progress demonstrated by the Research Scholar is considered unsatisfactory, the Doctoral Committee may declare the progress as **'Unsatisfactory'** which is equivalent to a **'Fail'** result. The Doctoral Committee shall approve and permit Supervisor to enter the credits earned in the Credit Accumulation Report. Convening the Doctoral Committee is the responsibility of the HOD.

F.1.4 Module Details

F.1.4.1 Module Delivery

F.1.5 Module Delivery Structure

Modules are delivered as per the time table announced in the beginning of the Programme.

F.1.6 Attendance Requirements

A student is required to have a minimum attendance of 75% to be eligible to write the Trimester End Examination (TEE). Students who fail to achieve the minimum attendance will be declared as "FAIL". A failed student is required to re-register, attend the module again and take up all the components of assessment at the next offering.

A shortfall in attendance, up to a maximum of 10%, may be condoned by the Dean of the relevant Faculty under special circumstances like medical emergencies, participation in sports, cultural activities, seminars, workshops and paper presentation etc. at the State, National or International level representing the University and with the prior permission of the concerned HOD.

F.1.7 Course Assessment

Students' performance is assessed through Component 1 (Continuous Evaluation CE) and component 2 (Trimester End Examination TEE). **The weightage for CE: SEE is 50:50.**

1. Component 1 (Continuous Evaluation CE):

- Two tests of 25 marks each will be conducted in each module. This is applicable for both general and vocational education.

2. Component 2 (Trimester End Examination TEE):

- A trimester end exam of 50 marks will be conducted in each module. An average of 40% is compulsory in each module. This is applicable for both general and vocational education
- An internship/project completion certificate and report is necessary for credits to be awarded. This will be assessed for a total of 50 marks. An assessment of 50 marks for the same will be conducted with external examiner from industry.

F.1.8 Eligibility for Appearing for TEE

- A student must have a minimum attendance of 75%
- Attendance in CE is compulsory
- A student not having a minimum attendance of 75% during regular trimester must re-register for the module in the next academic year

F.1.9 Pass Criteria

- A student must score a minimum overall of 40% (CE+TEE Combined) to pass the module
- Attendance in both CE and TEE is compulsory

F.1.10 Supplementary Term

- A makeup opportunity to clear the backlog credits will be provided at the end of the third trimester of the academic year

F.1.11 Promotion Criterion:

1. A student is permitted to carry-over all the courses from first and second trimester to the third trimester in the academic year.
2. A student has to earn all the credits from the first academic year for the award of Diploma (NSQF 5).
3. A student is promoted to the second year, provided the student has earned all the credits of the first year (Diploma).
4. A student must earn all the credits of second year for the award of the Advanced Diploma (NSQF 6).
5. A student is promoted to the third year, provided the student has earned all the credits of the second year (Advanced Diploma).
6. A student must earn all the credits of the third year for the award of the B.Voc. degree (NSQF 7)

F.1.12 Award of Class

F.2.2 Duration of the Programme

- Normal duration of the Programme is eleven months in the full time mode
- The maximum period a student is allowed to complete the Certificate Programme shall be double the normal duration of the programme, i.e., 22 months for Full-Time students.

F.2.3 Credit Scheme and Credit Structure

F.2.3.1 Credit Definition

- a. For theory classes (seminars, journal review): one credit is equivalent to a total of 15 contact hours.
- b. For laboratory / field work / workshops / project work/ and allied activities: one credit is equivalent to a total of 30 contact hours.

A student is required to earn a total of 50 credits to become eligible for the award of the Certificate.

F.2.4 Curriculum

The curriculum includes the:

1. **Programme specifications** document where the educational aims, course objectives, learning outcomes of the course and the detailed course structure are described; and
2. **Module specifications** document which contain the module title, learning outcomes, syllabus, teaching and learning methods and the assessment methodology for each of the modules.

F.2.5 Programme Specialization, Mandatory and Faculty Common Modules

F.2.6 Module Delivery

For students in the Full-Time route, the module is delivered from Monday to Friday of the week from 9 AM to 7 PM including mandated library/laboratory time with self-directed learning. The training for certificate course shall be full time with graded responsibilities in the management and treatment of patients entrusted to his/her care. The participation of the students in all facets of educational process is essential.

Prior to the commencement of a module, a detailed Module Session Time-Table shall be issued to the students.

Every candidate should take part in

- Seminars,
- Group discussions,
- Journal review meetings,
- CPC and inter departmental meetings.
- Case demonstration,
- Patient Care in Dental Clinical and Medical Hospital setup,
- Field visits,
- Continuing Dental Education Program
- Conferences/ Workshop/Advanced Courses

Every candidate should participate in the teaching and training Programme of undergraduate students. Training should include involvement in laboratory and experimental work, and research studies.

F.2.7 Attendance Requirements

Considering the Programme work load, students are advised to attend all classes conducted during a year i.e., 100% of attendance is desirable. A 15 % condonation of the attendance (up to 85% of attendance) can be sanctioned by the Dean on the recommendation of the course director and concerned module leader for contingencies including medical emergencies. However, a shortfall in attendance, up to a maximum of further 10% (up to 75% of attendance) may be condoned by the Dean of the relevant Faculty under special circumstances like, participation in sports, cultural activities, seminars, workshops and paper presentation etc. at the State or National level representing the University and with the prior permission of the concerned HOD and intimation to his/her Proctor. An additional 10% of condonation is considered with penalty at the discretion of the Dean.

Attendance for the qualifying examination is compulsory for obtaining the certificate. There is no provision for re-examination or any kind of re-consideration.

F.2.8 Module Assessment

At the end of the Programme, Final Assessment will be conducted in both theory and clinical components.

- Theory Component is a written examination and has a weightage of 30%
- Clinical Component has two parts; part A is a case presentation and has a weightage of 35% and part B is a log book assessment at the end of each module and has a weightage of 35%.

A student is required to score a minimum of 40% in each component as well as overall for a pass.

F.2.8.1 Examiners:

The Directorate of Training and Lifelong Learning together with the Dean of Faculty is required to constitute a **Board of Examiners (BoE)** for the purpose of assessment of students' performance. The BoE, comprising Internal and External examiners, is headed by a Chairman.

Normally, the Programme Director, offering the course, is the Chairman of BoE as well as the internal examiner. The Board of Examiners (BoE) is responsible for:

- Review of question papers and evaluation of answer scripts
- Laboratory/Clinical/Project assessment
- Supervision of Written Examinations and Conducting Laboratory Examinations

A student is required to score a minimum of 40% in each of the components and 40% overall for successful completion of a module and for earning the corresponding credit(s).

F.2.8.2 Question Paper

The setting of question papers is the responsibility of the Programme Director. Question papers for Final Assessment shall be reviewed and approved by BoE.

F.2.8.3 Second Assessment and External Review

Theory: Each answer script is first assessed by the internal examiner. All the answer scripts of a given course are then to be moderated by an external examiner. The first assessor or assessing team is required to fill in the evaluation data and prepare the Post Programme Assessment Report (PCAR).

Clinical: Assessment of Log Book will be done by the internal examiner and moderated by another faculty from the Programme while assessment of Case presentation will be by both internal and external examiner.

F.2.8.4 Feedback on Assessed work

After completing clinical assessment of the module, the module teaching team along with the concerned course director should provide face-to-face feedback to the student regarding his/her performance after handing over the assessed documents on a prescheduled day. The awarded marks and distribution pattern of the course will be reviewed by the Director of Training and Lifelong Learning with Dean of the Faculty at the end of the course.

F.2.9 Failure and Re-registration

A minimum of 40 % marks in each of the assessed components are required for successful completion of the course. A student failing in any one of the components will be declared 'FAILED' in the course. A failed student who has fulfilled the attendance criterion is eligible to re-sit in the next provided opportunity declared as **RS (Re-Sit)** category.

Note: Students appearing for Re-Sit examination are required to pay the prescribed examination fees.

There is no provision for a re-valuation or re-submission of any of the assessment components for a failed course. A maximum of 3 attempts, including the first attempt, are permitted for successful completion of the course

F.2.10 Award of Class

The final award will include a mention of class based on the average marks scored by the student during the course. The basis for awarding classes is shown in the Table below:

F.2.11 Missing a module / failure to complete a module:

If a student is unable to complete a module due to any reason leading to non-assessment, the student is required to re-register for that module in the next offering.

F.2.12 Termination from the course

A student will be directed to discontinue the Programme and leave the University on the following grounds:

- a. Failure to meet the standards of discipline as prescribed by the University from time to time;
- b. Failure to complete the Programme within the prescribed maximum duration permitted by the University's regulations.

F.3.3.4 Attendance Requirements

- The mandatory minimum attendance is 80% of the classes in each of the courses in a given trimester.
- The student will not be allowed to appear for TEE if the attendance requirement is not met with. However, a shortfall in attendance, up to a maximum of 10%, may be condoned by the Dean of the relevant Faculty under special circumstances like medical emergencies, participation in sports, cultural activities, seminars, workshops and paper presentations, etc. at the state, national or international level representing the University and with the prior permission of the concerned HOD and intimation to his/her Proctor.
- The basis for calculation of attendance shall be the period prescribed by the University in its annual calendar of events.
- For the first trimester, students' attendance is computed from the date of registration to the Programme.

F.3.3.5 Curriculum

The curriculum includes the following:

- Programme Specifications (PS):** This document contains the Programme aims, objectives, learning outcomes and the detailed Programme structure are described.
- Course Specifications (CS):** This document contains the course title, course outcomes, course contents, teaching and learning methods, and recommended course resources for each of the courses.

F.3.3.6 Course Assessment

During each trimester, students' performance is assessed through CE and TEE. CE and TEE components carry equal weightages. **The CE: SEE is 50:50.**

- i. **CE:** *This* includes term tests, assignments, Viva-Voce, quiz, seminars, mini projects, and other such evaluation methods designed for specific courses and conducted as per the norms of the University for the Assessment.
- ii. **TEE:** This includes written/laboratory examinations conducted as per the norms of the University for Assessment.

F.3.3.1 Eligibility to TEE

- A student will be eligible for the TEE under the following circumstances:
 - i. Has satisfied the attendance criteria of 75 %
 - ii. Has scored a minimum of 40 % in CE and has satisfied the attendance requirement

F.3.3.2 Pass Criterion and Earning of Credits

- i. **Core Theory or Professional Core Elective Courses:** A student is required to score a minimum of 40% marks in CE, and a minimum of 40% marks in TEE, and a minimum of 40% marks together to pass a core (or a Professional Core Elective) course.
- ii. **Open Elective Courses:** A student is required to score a minimum of 40% marks in TEE and a minimum of 40% marks in CE and TEE together for a pass. Attendance in both CE and TEE is compulsory.
- iii. **Laboratory Courses:** A student is required to score a minimum of 40% marks in CE, and a minimum of 40% marks in TEE, and a minimum of 40% marks together to pass a laboratory course.
- iv. **AECCs:** A minimum of 40% marks in CE, or a minimum of 40% marks in TEE, or a minimum of 40% marks in both components together is required for a pass in AECCs.

Attendance in both CE and TEE is compulsory for all courses.

- v. A student shall be considered to have successfully completed a Course and earned the credit(s) if he/she has passed the Course.

F.3.3.3 Credits Not Earned in a Course

A student will be declared “Failed” in a course under the following circumstances:

- a. Not scoring a minimum of 40% in TEE although he/she has satisfied attendance and CE requirements.
- b. Is absent for TEE but has satisfied attendance and CE requirements.
- c. Has not satisfied the attendance requirement (not eligible for TEE).
- d. Has not scored a minimum of 40% in CE, but has satisfied the attendance requirement (not eligible for TEE)
- e. Has scored at least 40% in CE, but has not satisfied the attendance requirement at the end of the trimester (**Note:** Such a student is not eligible to appear for TEE and the student’s CE score will be made null and void).

F.3.3.4 Supplementary Term

A Supplementary Term is typically half the duration (6 weeks) of a Regular trimester and a student can register for a maximum of 5 credits. Students who could not pass in certain courses during the Regular Trimester(s) can register during a Supplementary Term to make up for the credit deficiency. Courses offered in a Supplementary Term will be decided by the Course Leaders in consultation with the HOD/Dean.

A student can Re-Sit (RS) or Re-Register (RR) for a Supplementary Term.

1. **Re-Sit (RS):** If a student has the attendance eligibility in any course in a regular trimester and has met the minimum requirement of CE in that course during the regular trimester, then the student is required to register for a RS to appear in the TEE component with the earlier CE carried forward to the next opportunity (either during the Supplementary Term

or a regular trimester in which the particular course is offered within a year of the completion of previous academic duration).

2. **Re-Register (RR):** If a student does not have the attendance eligibility in any course in a regular trimester, then the student is required to RR to attend the classes in the Supplementary Term and also satisfy the requirements of CE to appear for the TEE in that course. This is applicable regardless of whether the student has met or not met the minimum requirement of CE in that course during the regular trimester.
3. **Additional Registration Fees:** All students registering (RS or RR) for courses during a Supplementary Term are required to pay the prescribed fees in addition to the annual fees.

F.3.3.5 Promotion Criterion:

1. A student is permitted to carry-over only one given course from the first regular trimester to the second regular trimester in the given academic year.
2. The student is promoted to the third trimester, provided the student has not more than 5 backlog credits from the earlier first & second trimesters.

F.3.3.6 Ability Enhancement Compulsory Courses (AECC):

The courses listed below are required to be successfully completed by earning credits for the award of the Degree.

F.3.4.2 Attendance Requirements

A student is required to have a minimum attendance of 75% to be eligible to appear in the module end examination. Students who fail to achieve the minimum attendance will be declared as “FAIL”. A failed student is required to re-register, attend the module again and take up all the components of assessment at the next offering.

A shortfall in attendance, up to a maximum of 10%, may be condoned by the Dean of the relevant Faculty under special circumstances like medical emergencies, participation in sports, cultural activities, seminars, workshops and paper presentation etc. at the State, National or International level representing the University and with the prior permission of the concerned HOD.

F.3.4.3 Curriculum

The curriculum includes:

- i. **Programme specifications** document where the Programme aims, objectives, learning outcomes and detailed Programme structure are described; and
- ii. **Module specifications** document which contains the module title, learning outcomes, syllabus, teaching and learning methods and the assessment methodology for each of the modules.

F.3.4.4 Module Assessment

Performance in every module will be assessed on the following two components:

- **Component - 1**

Assignment or Equivalent (50% weight)

- **Component -2**

Trimester End Examination (50% weight)

A student is required to score a minimum of 40% in each of the components and 40% overall for successful completion of a module and for earning the corresponding credit(s).

F.3.4.5 Module Delivery Structure

F.3.4.6 Eligibility to MEE

- A student will be eligible for the MEE under the following circumstances:
 - i. Has satisfied the attendance criteria of 75 %
 - ii. Has scored a minimum of 40 % in CE and has satisfied the attendance requirement

F.3.4.7 Pass Criterion

A student is required to score a minimum of 40% in CE and an individual minimum of 40% in MEE and an overall minimum of 40% to pass the module.

F.3.4.8 Failure and Re-Registration

A minimum of 40 % marks in the assignment and a minimum of 40% marks in the written

examination are required for successful completion of a module. A student failing in any one of the components will be declared 'FAILED' in the module. A failed student who has fulfilled the attendance criterion is eligible to Re-Sit under the fast track scheme. There is no provision for a re-examination or re-submission of any of the assessment components for a failed module.

F.3.4.9 Fast Track Scheme

The Fast Track Scheme has been devised to provide a Re-Sit opportunity for failed students who have met the attendance requirement.

The Details of the Fast Track Scheme are as under:

- i. The scheme is available for those students who are carrying out their internship but have a backlog of module(s).
- ii. A schedule for the Fast Track scheme will be notified, well in advance, by the respective Faculty.
- iii. A student who has failed need not attend the classes and lab sessions but will have to appear for all the components of the module assessment, viz., written test, assignment, laboratory/field work, as the case may be.
- iv. The assessment method is the same as that for regular modules.

F.3.4.10 Promotion Criterion:

- i. A student is permitted to carry-over all the module from the first regular trimester to the second regular trimester in the given academic year.
- ii. The student is promoted to the third trimester, provided the student has not more than 5 backlog credits from the earlier first and second Trimesters.

F.3.5 Award of Class

The final award will include a mention of class based on the average marks scored by the student during the course. The basis for awarding classes is shown in the Table below:
