to the Sole Trustee a sum of Rs. 15,000/- (Rupees fifteen
thousand), Rs. 1,000/- (Rupees one thousand) by each of the
Authors, to be held upon Trust together with all the income
accruing therefrom and all the accumulations and accretions
thereon for the intent, purposes and objects herein con-
tained.

2. The name of the Trust shall be "GOKULA EDUCATIONAL FOUNDATION (MEDICAL)".

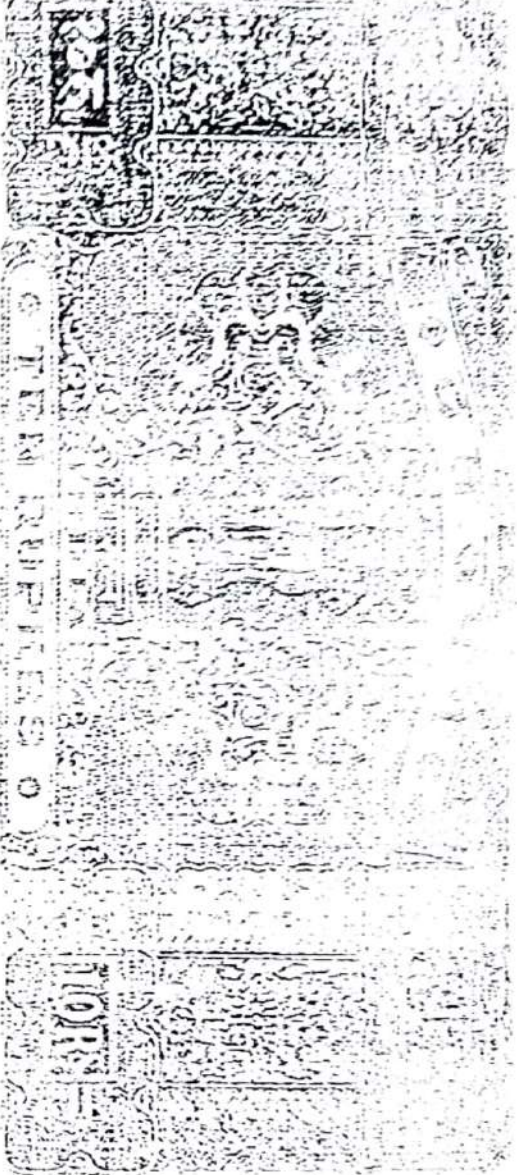
3. The objects of the Trust shall be:

a) EDUCATION: that is to establish, maintain, run and manage colleges and institutions for the imparting of medical education embracing medical, surgical and nursing sciences including all allied or related subjects such as radiology, physiotherapy, preventive or psychometric medicine and to promote other studies and disciplines regarded as related to or furthering the cause of medical education and healing sciences in general.

b) To establish, provide, maintain and run training institutions, creches, health centres and institutes dealing with matters of public health - rural and urban, and for the training of medical, surgical, gynaecological, radiological, ophthalmological and dental students, nurses, health

... persons, technicians and personnel of all kind required for the carrying out of the work of medical colleges and other educational institutions.

... To establish, equip, maintain and conduct research centres, institutes, laboratories, observatories, dispensaries, hospitals, clinics, nurseries, morgues etc., which are adjuncts to medical education and to establish and maintain health centres in rural and other areas.

... To carry out research in the fields of medicine including the various systems of medicine like allopathy, ayurveda etc., and to set up necessary institutions, and centres for the carrying out of such research.

... Generally to undertake do and carry out all other things necessary or incidental for the effective achievement of the primary object namely medical education and the incidental objects heretofore referred to.

The Trust hereby created shall be irrevocable.

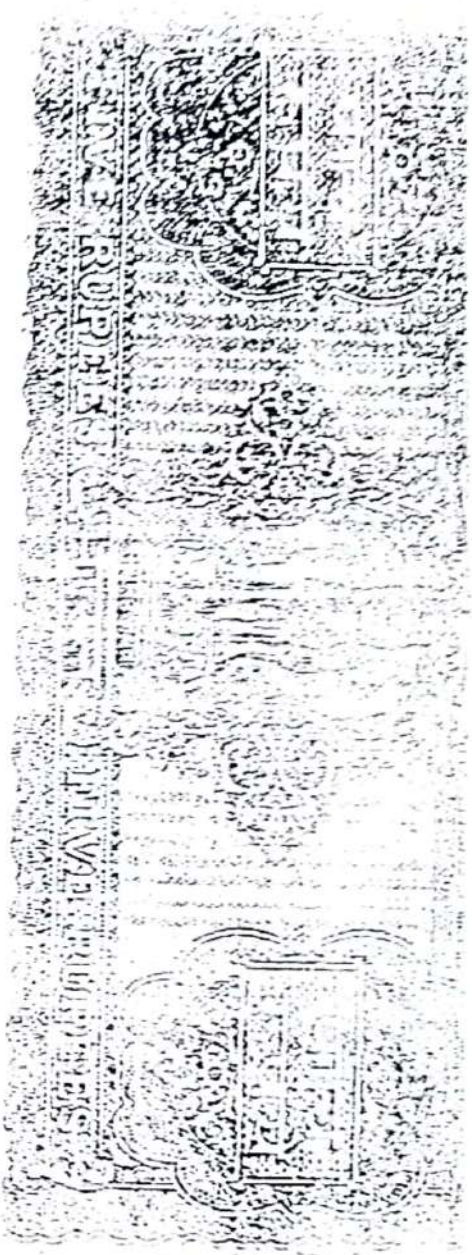

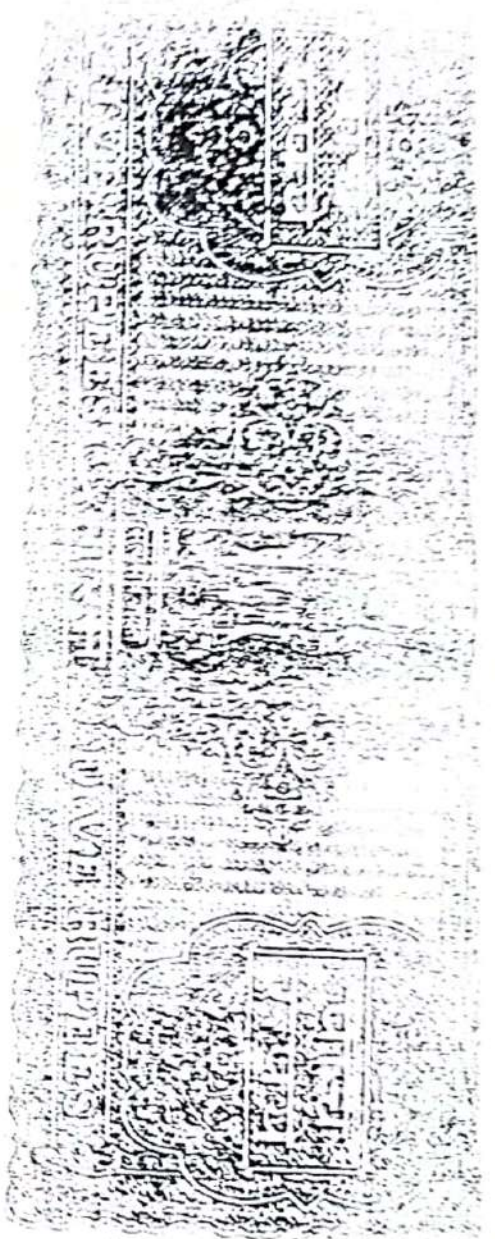




- 5. The term 'Trust Property' shall mean and include the said sum of Rp.15,000/- (Rupee fifteen thousand) set apart by the Author and further grants, donations, or contributions of money and/or property - movable or immovable, that may be made by the founder or by others from time to time and other accumulations and accretions thereof in whatever form they may be varied from time to time.
- 6. The Trust Property shall vest in the sole trustee who shall hold, manage and administer the Trust in accordance with the terms and provisions hereof.
- 7. Shri. M.S. Ramoan will be the sole trustee for life. The sole trustee may co-opt other trustees, without prejudice to the generality of the power and sole trustee shall have the following powers:
 - a) To procure and control the services of professors, lecturers, physicians, surgeons, experts, demonstrators, etc.

to borrow funds for the work of the Trust from any bank, financial institution or other person upon such terms and conditions as may be approved proper and offer or charge the property of the Trust, by way of security for the reimbursement of the funds borrowed and otherwise of the work of the Trust;

to employ clerks and other employees, agents, Bankers, lawyers, accountants, and others on such remuneration as may be thought fit.

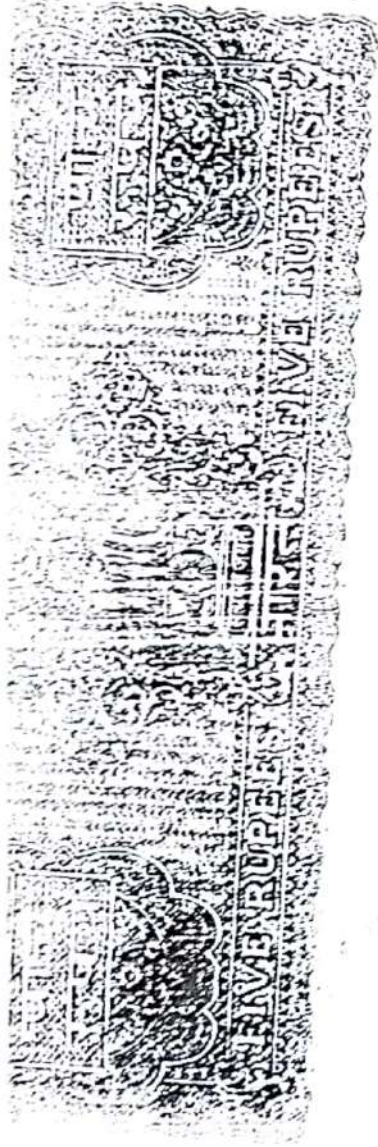

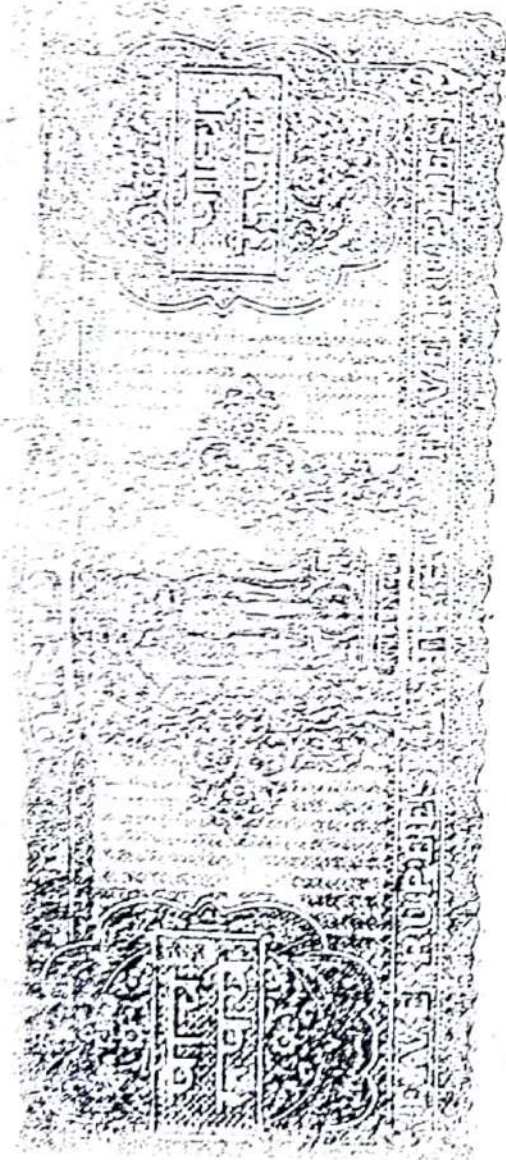

b) The Committee of Advisors shall advise and assist the Chairman in the discharge of the powers and functions vested in him under these provisions. They shall work under the Chairman's overall supervision.

c) The Chairman shall be entitled to fill up the vacancies in the Committee of Advisors by nominating any persons of his choice.

d) The quorum for the Meeting of the Advisors shall be three and the Chairman shall preside over the Meetings of the Committee. The decisions of the Committee shall be taken by majority vote and the Chairman shall take them into effect.

10. In the absence of the Chairman, the Committee may meet and every such meeting to act as Chairman.

11. The Trustees shall keep proper books of accounts of the income and expenditure of the Trust, which shall be closed every year. They shall be audited by a Chartered Accountant and a Certificate obtained.

12. The Trustees shall at all times stand indemnified in respect of any act that may have been bonafide done in the furtherance of the objects of the Trust, but they shall not be entitled to any remuneration.

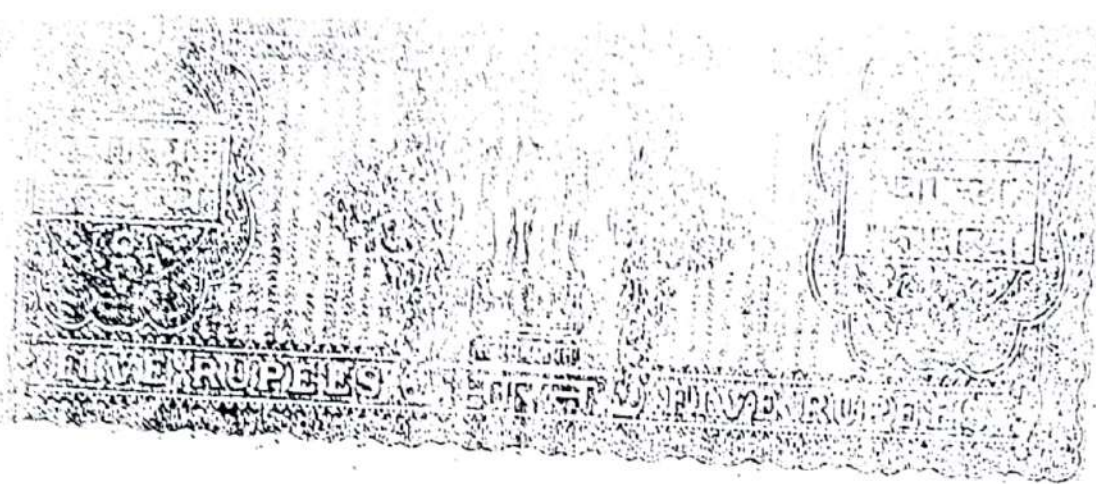

15. A minutes book shall be maintained at the office of the Board of Trustees. Minutes of all meetings, appointment and entry into the office of every new trustee and all other proceedings of the Board of Trustees shall be entered and recorded in such minutes book and shall be signed by the Chairman of the meetings either at the conclusion thereof or at a subsequent meeting when they are duly confirmed.

17. The Managing Trustee shall at all times during his continuance in the office, have the right to delegate his powers to any of the remaining trustees or to other attorneys or agents, with the prior consent of the Board of Trustees.

18. The accounting period of the Trust shall be the year ending 31st March.

19. The Trustee is empowered to frame and alter the rules governing the administration of the Trust in consultation with the Committee of Advisors in a manner not inconsistent with the provisions of the Trust Deed.

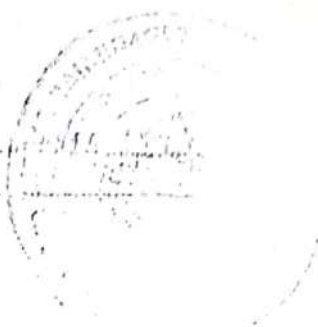
